The 58th Korea International Design Award will be held in the following manner, in compliance with Article 5 of the Industrial Design Promotion Act and Article 8 of its Enforcement Decree:

## Adults and University Students

### A. Call for Entry

Any designs in 2D or 3D images and/or videos that fall into one of the seven disciplines of the competition and will neither be released into markets nor produced for sale as of the deadline of the award year 's registration date (June 30, 2023).

**Eligibility** ※ For any individual who falls under (1) or (2) below

- (1) Any individuals regardless of nationality
- (2) Adult or University (Graduate) Student

#### Adult Division

As an individual work (up to 5 persons per entry)

#### Entry Fees

KRW 50,000

#### University (Graduate) Student Division

As an individual work of student (up to 5 persons per entry)

#### Entry Fees

KRW 30,000

- ※ Those who are currently enrolled in school or on leave of absence
- ※ Only documentation (certificate of enrollment and leave of absence) issued within the last 6 months is allowed, and all entrants must submit one per person
- ※ If even one member of the team does not qualify as a student, the project will be presented in the [Adult] division

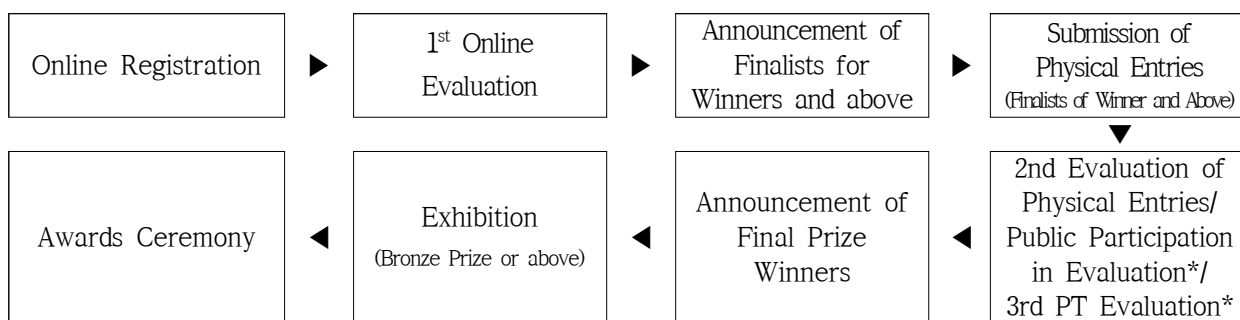
#### Common Rules

- ※ After the application deadline, entrants' information cannot be modified
- ※ There is no restriction to the number of entries
- ※ A work can be submitted jointly by up to 5 persons

#### Common Rules for Fees

- ※ The entry fee is charged per entry

## B. Procedure



### \*What is Public Participation in Evaluation?

A procedure in which the general public can directly participate (online) in assessing the prize contenders chosen through the first and second evaluations via the KIDP awards website. The findings of the evaluation will be reflected in the final evaluation for 10% of the total score.

### \*What is PT Evaluation?

The award-winning candidates chosen in the first and second rounds are freely presented by the entrants within the time limit, and the external judges evaluate them based on the third screening criterion to determine the final prize winning entries. Materials submitted for presentation screening will be informed in a separate notification.

## D. Submission Method

### Step 1: Online Registration

Image panel upload: Up to 5 images (1 main image, 4 auxiliary images)

The images submitted will be utilized for the 1st Round of Evaluation to choose the finalists of Winner and above, and they cannot be modified after the submission deadline.

※ To examine works and issue confirmations in all accounts, you must enter the ID of a participating designer through the ID search option.

※ Any inaccuracies about the participating designer or other information are the responsibility of the entrants, and the information entered cannot be changed after the registration period. As a result, please double-check the information you enter while registering online.

#### - Registration Period

May 1 (Sun) - June 30 (Thu) 12:00 am

※ Additional submissions or amendments after the submission date are strictly prohibited.

#### - Information Provision

The designer's information will be provided to judges and for catalog and online exhibition.

Therefore, the correct information (entry name, entry description, designer name, affiliation, position, contact information, address, etc.) must be entered.

※ Please keep in mind that the information entered cannot be revised after the registration deadline.

※ Please fill in the detailed address as well, as it will be required for future catalogs and listings.

#### - Image Specification

1,000 pixels on the longer side, either height or width, Up to 3MB, JPG, RGB file, 72~150dpi

※ If the above requirements are not followed, the image may not be displayed on the screen during online evaluation, which is the entrant's responsibility.

※ Image for catalog (to be requested separately for catalog production): within 300 x 300mm, CMYK, 300dpi

#### - Image Recommendations

Configure and express freely without limitations

Image composition such as background and text insertion is allowed

We accept photos or digital renderings of artworks.

#### - Digital Content

Videos cannot exceed 5 minutes in playback time.

Up to 50MB, MP4, 5-minute or shorter playback time (submit URL link separately if needed)

#### - Entry Description

Entry descriptions must be written in both Korean and English to help judges and viewers understand the work during the judging and online exhibition.

※ Name, title and entry description in English is required

## Step 2: Physical Submission and Return of Submissions

The juried artworks or those at a higher level, which will be separately announced for judging for special selection and qualified candidates for a main prize, will be used in the second judgment along with tangible works to select the final list of winners.

※ Only the finalists for Winner and above from the 1st Round of Evaluation are required to submit their entries.

### - Submission Period

August 11(Fri) - 16(Tue), 10:00~17:00 ※Submissions must be received no later than 11:59 a.m. on August 16.

### - Place of Submission

B1 Exhibition Hall, Korea Design Center, 322 Yanghyeon-ro, Bundang-gu, Seongnam-si, Gyeonggi-do

※ Entry submission in person or by mail is accepted. The deadline indicates when physical materials must arrive at the Center, and any damage or destruction of materials caused by or resulting from mailing shall be the entrant's responsibility.

※ After inputting the application number in the back of the entry submission, mail it by post within the application time.

### - Regulations on Entry Submission (Select 1 from Board or Model / Both are allowed for submission)

#### 1) Regulations on Board Work

**Guideline: 5T foam board, 1 sheet in A1 size (594 x 841mm, Horizontal or Vertical, Up to 3 sheets allowed if it is in series)**

Include a description and images that help grasp the design concept and designer's intent

※ Except for foam boards, acrylic, hard boards, wood panels and frames are prohibited from submission

#### 2) Regulations on Model Work

**Size Spec: Up to 100 cm in size for length, width and height**

※ For any entry that may be damaged or lost, auxiliary devices (such as a transparent case) must be installed by the entrant and KIDP does not bear any responsibility.

※ If the subject of the evaluation in the digital media/contents section is a video, it may be used as the video uploaded during the initial online registration or submitted via USB

(However, if it is submitted for a category other than digital media/contents, it may be inserted in products such as a laptop, tablet, or smartphone that can play the video).

### - Return of Submissions

## ◆◆ Notes on Submission and Return of Entries ◆◆

1. No personal information of the entrant (name, affiliation, etc.) shall be described on the front side of any entry. However, be sure to provide the online **registration number (e.g. K2021A010001), entry discipline, entry name, entrant name, affiliation, and contact information** on the back side of the entry (foam board).
2. All entries must be returned within the returning period. The host and/or organizing institution(s) shall not be liable for any damages or loss related to the entries that are not removed during the designated Return of Submissions period. All entries that are not returned during the periods will be discarded.

- ※ As for the second reception, judging, or/and return of an artwork, it is impossible to carry it out after the permitted period due to limited space for exhibition and storage.
  - ※ When requesting the return of an artwork, please inform us of your reception number, recipient name, contact, and address via the instruction mail.
  - ※ Carrying out by mail is not allowed for an artwork that is fragile, consists of or contains small accessories, or is susceptible to damage or loss.
3. As entries can be damaged, destroyed, or lost during postal transit, returning them by mail is not possible.
- ※ We provide parcel delivery of an artwork only for the convenience of a submitter. However, we are not responsible for any damage or loss that occurs during transportation. Therefore, your discretion is required when using the service.
4. For any entries that may be lost, damaged, or destroyed, entrants must prepare safety equipment, and KIDP shall not be held liable for any loss, damages or destruction of entries during the exhibition, removal, or judging process.
- ※ Expensive, valuable, perishable, and deteriorating items (such as food) are not accepted for registration.

## Step 3: Submission of Presentation Materials

This is the stage where the final qualification for award-winning is determined. Artworks that have placed third (or higher, earning the bronze prize or above) should be submitted and presented during the 3rd round of judging for presentations.

Please note that only the winners who received the bronze prize or higher, as named in the 2nd round announcement, are required to submit their artworks.

※ the schedule and details are subject to change depending on the progress situation.

※ If your submission includes a video, please indicate in the file name the page number where it is located and attach it separately.

※ Also, ensure that you attach the font file used for your PPT submission.

Schedule: September 12 (Tue) - 13 (Wed), 10:00 am to 6:00 pm

The venue: B1 Exhibition Hall, Korea Design Center.

Presentation Time: Each presentation is allotted around 10 minutes. A separate email will be sent regarding presentation schedules and guidelines for each artwork.

※ Up to one more person, except a presenter, can be accompanied for the purpose of helping with work demonstration, joint presentation, etc.

※ If you plan to make a presentation and demonstrate a tangible artwork simultaneously, please contact us to arrange for an exhibition stand or table in advance.

## H. Benefits of Prize Winners

They will receive a winner package which includes an award certificate and art brochure, as well as a cash prize. Additionally, they will be appointed as government-recognized invited/recommended designers and be given various benefits, including online and offline exhibitions, support for linkage service with commercialization. The winners will also have opportunities to promote their artworks and business performance through press/broadcast and online interviews.

### I Winner Package



- For who: Prize receivers of Winner and above
- Winner package is composed of certificate, catalogue and more
  - ※ The art brochure is published and sent to them at the end of the year.

### I Online and Offline Exhibition



- For who: Prize receivers of Bronze Prize and above
- Online display using an integrated contest site and multiple social media platforms
- Offline display in various exhibition and event venues, including Design Korea
  - ※ The qualification for the online exhibition is limited to the juried artworks and above.

### I Review of Support for Commercialization



- For who: Prize receivers of Winner and above
- The winning artworks are reviewed and considered by investment-related experts for their commercialization.
- Supported to build a business model including mentoring, and Opportunities are provided for investment briefings (pitching programs)
- Additional points are given for the preliminary startup package business project (the Korea Institute of Startup & Entrepreneurship Development)
- Interviews and promotion activities are arranged later with startup-related media, SNS, etc.
  - ※ When applied, the artworks are reviewed and selected by those who responded to commercialization-related demands.
  - ※ A winning entry gets additional point: 1 for a juried work and 2 for a ministerial award or higher.

## I Support for International Internship

---



- **For who: Prize receivers of Silver Prize and above**
- Provided with an entitlement to the application for the overseas internship support program, which selects domestic designers and sends them to the foreign companies that need them.
  - ※ Maximum of 1 person per entry, Exemption from document review (yet, it could differ depending on the scope of business operation).
  - ※ Refer to the KIDP Overseas Internship Support Project announcement for more information (qualifications, timetable, etc.).
  - ※ The winners of first prize(gold) and above cannot apply for the overseas company visit program if applying for the overseas internship support program.

---



- **For who: Prize receivers of Gold Prize and above**
- Supporting tour of design companies in overseas
  - ※ Details (schedule, visit companies, etc.) is be separately announced later and is subject to change depending on the progress of the program.
  - ※ For a joint submission, up to 2 persons per a winning entry can apply.

## I Excellence Design School Award

---



- **For who: Competition participating universities or graduate schools**
  - Winners or above are converted into points, and the institution with the greatest score is named the best university of the year, **receiving a certificate of excellence and \$1 million in prize money.**

## I. Regulations on Intellectual Property Rights Protection

- ① In the event of unlawful conduct such as plagiarism of another person's work, the entry will be terminated in accordance with the 'Guidelines for Reconsideration of Plagiarized Artwork in Competition', and penalties such as three-year entrance restriction will be enforced.
- ② If you submit cited work, plagiarized work, proxy work, or previously awarded works without the permission of the intellectual property rights holder or in possession of intellectual property rights, or if you do not follow the competition organizer's guidelines, your application and prize winning will be cancelled.
- ③ The person who submitted the entry is solely responsible for any disputes with the intellectual property rights (design rights, copyrights, etc.) of the submitted product.
  - ※ When submitting work that may result in a dispute, we advise that you submit it after completing the procedure to safeguard your rights.

## J. Regulations on Submission and Return of Submissions

- ① Entrants will be notified of critical matters and issues relating to the exhibition via the phone number or email address provided during online registration, so please provide accurate contact information.
  - ※ KIDP will not be held liable for any consequences resulting from missing or inaccurate contact information.
- ② Even if there is a delay, waiting time, error, and/or system failure due to overload or a high number of entrants, online registration or physical entry submission after the deadline will not be accepted. As a result, it is strongly advised that you register and physically submit your entries at least a day before the deadline.
  - ※ Due to the high volume of inquiries on the deadline day of submissions, it may be impossible to respond on the day of submissions, so please query via email before the deadline to ask about the application or revision details.
- ③ Except for online exhibits, all submissions must be removed within the Return of Submissions period, and KIDP will not be held liable for any loss, theft, damage, or destruction of entries that are not removed by the deadline. All entries that are not removed by the deadline will be discarded.
  - ※ When a submission is chosen for exhibition, the entrant must comply with KIDP for future procedures such as exhibition, transfer, and removal.
- ④ For any entries that may be lost or destroyed, entrants must prepare safety equipment, and KIDP shall not be held liable for any loss or destruction of entries.
  - ※ Expensive, valuable, perishable, and deteriorating items (such as food) are not accepted for registration
- ⑤ There is no limit to the number of submissions per individual or group, and multiple entries are permitted.
- ⑥ Up to 5 persons can participate in a group entry.
- ⑥ Works that have already been awarded and submitted in other contests may also be submitted, but KIDP is not responsible for any disadvantages created by duplicate submissions due to different contest rules.
- ⑦ All event-related matters and issues are posted and disclosed on the award website.

- **Passing the 1<sup>st</sup> Evaluation (selection):** Entry with an average score of 60 or higher for each judge

The criteria for passing the first evaluation are selected in the order of the highest score of each judge's total score.

\*The highest / lowest scores are excluded

- **Passing the 2<sup>nd</sup> Evaluation (special selection):** Among entries that passed the 1<sup>st</sup> Evaluation, an entry with an average score of 60 or higher for each judge

Award-winning entries are selected in order of the highest score
